

Health Care "Crisis"?

Looking back at the Covid-19 pandemic, have you wondered what exactly is the nature of the heath care "crisis" we have been going through, and which has been so widely reported in social media and "news" outlets around the world?

Stand for Health Freedom

Amid growing safety concerns, Robert F. Kennedy, Jr. and Dr. Meryl Nass, on behalf of Children's Health Defense (CHD), filed a **Citizen Petition** with the U.S. Food and Drug Administration (FDA) asking the agency to immediately revoke the Emergency Use Authorizations (EUAs) for COVID vaccines and to refrain from licensing them. https://www.regulations.gov/document/FDA-2021-P-0460-0001

This is an official Citizen's Petition that goes through a formal process. The FDA must respond, and if not satisfied with the response, the petitioner can take the matter to court.

The Petition states:

- FDA should revoke all EUAs for any COVID vaccine because the current risks of serious adverse events or deaths outweigh the benefits, and because existing drugs provide highly effective prophylaxis and treatment.
 - FDA should immediately stop allowing minors to participate in COVID vaccine trials.
- FDA should immediately revoke approval that pregnant women may receive any EUA or licensed COVID vaccines and issue public guidance to that effect.
- FDA should amend its guidance for the use of the chloroquine drugs, ivermectin and any other drugs demonstrated to be safe and effective against COVID, to comport with current scientific evidence of safety and efficacy, and issue notifications to all stakeholders.
- FDA should issue guidance to the Secretary of Defense and the President to NOT grant an unprecedented presidential waiver of prior consent regarding COVID vaccines for our service members.
- FDA should issue guidance affirming that all citizens have the option to accept or refuse administration of investigational COVID vaccines without adverse work, educational, or other non-health related consequences.
- Pending revocation of COVID vaccine EUAs, FDA should issue guidance that all marketing and promotion of COVID vaccines must refrain from labeling them "safe and effective."

A comment page will open. Type your comment into the box, or copy and paste your prewritten comment, or attach a file of your comment. Tips:

Your remarks can be long or short; the point is that we want the agency to receive an overwhelming volume of earnest and polite comments expressing support for the petition and urging implementation of the measures requested.

If you personally know of anyone harmed by any of the vaccines, please include those details. This is open public comment, available for the world to see, so do not include any personally identifying details
